Plan Descriptions

A description of how parents, teachers, and school staff were involved in the development of the plan.

The staff was directly involved in the development of this plan. The Board of Directors for the school is made up of a majority of parents as well. They have presented with this plan and be asked for their input before granting approval.

A description of how students will be identified and the needs of students will be assessed.

The Yosemite-Wawona Elementary Charter School is a TK-6 multi-grade school that utilizes a Montessori approach to individualized learning. Currently, there is 1 certificated teacher and and 1 part time instructional aide to serve these students. Staff is intimately aware of the strengths and weaknesses of each student enrolled and is able to make individualized adjustments to the learning program as needed on a daily (or even hourly) basis. As a matter of instructional practice, students are assessed all day - everyday. Students representing the demographic groups of low income students, students with disabilities, students who are disengaged, and students who are performing below grade level are represented in the student population. Students identified in at least one of the priority categories (and this includes nearly 100% of the student population) will receive priority to participate in the expanded learning program by receiving services and support through this program's offerings. CAASPP results for 2023-24 indicate an overall weakness for the student population in the area of mathematics. It was decided that this is the area that will continue to be focused on through the Expanded Learning Opportunities Grant funds - though academic support will be provided in any subject as individual students needs are considered.

Because of the small class size, communication between staff and the school's families is easily accomplished. Often, information on students is shared face to face at drop-off or pick-up. Parents attend goal setting conferences 3 times per year where they and their child(ren) set goals (both academic and social-emotional) and monitor the progress towards those goals at subsequent meetings. Additionally, student information about school is shared through the school website and Facebook page. Phone calls and texts are shared regularly. Communication with parents about anything going on at school is a strength. Communication with parents will focus on both academic and social-emotional deficits experienced by students - especially those in the targeted demographic groups. Regular and on-going communication with the parents of students will continue with this voluntary program's offerings.

The expanded learning program will include all, but not be limited to the following:

School Year Learning Recovery and Acceleration Program:

The focus in this program area includes accelerating progress and achievement to close learning gaps through the implementation, expansion, and enhancement of learning supports and services.

Implementation of IXL supplemental curriculum in math.

Use of other supplemental digital curriculum and licenses to support core curriculum and classroom instruction.

Purchase of additional equipment for support instruction and learning activities planned for students.

Financial support for extended day educational fieldtrips

Integrated Student Supports to Address Other Barriers to Learning and Achievement Program:

Address the needs in the school breakfast program and the healthy snacks support to ensure that students are nutritionally ready to learn.

Address Social-Emotional learning through the adoption of a program that allows students to further develop social skills and expression of feelings.

Elementary and Secondary School Emergency Relief (ESSER) funds are federal restricted categorical funds. As such, they will supplement and not supplant the activities identified in this plan and funded the the Expanded Learning Opportunities Grant (ELO).

Expanded Learning Opportunities Grant Plan Instructions: Introduction

The Expanded Learning Opportunities Grant Plan must be completed by school districts, county offices of education (COE), or charter schools, collectively referred to as LEAs, that receive Expanded Learning Opportunities (ELO) Grant funds under California Education Code (EC) Section 43521(b). Instructions: Plan Requirements

An LEA receiving ELO Grant funds under *EC* Section 43521(b) is required to implement a learning recovery program that, at a minimum, provides supplemental instruction, support for social and emotional well-being, and, to the maximum extent permissible under the guidelines of the United States Department of Agriculture, meals and snacks to, at a minimum, students who are included in one or more of the following groups:

- low-income,
- English learners,
- foster youth,
- homeless students,
- students with disabilities,
- students at risk of abuse, neglect, or exploitation,
- disengaged students, and
- students who are below grade level, including, but not limited to, those who did not enroll in kindergarten in the 2020–21 school year, credit-deficient students, high school students at risk of not graduating, and other students identified by certificated staff.

For purposes of this requirement

- “Supplemental instruction” means the instructional programs provided in addition to and complementary to the LEAs regular instructional programs, including services provided in accordance with an individualized education program (IEP).
- “Support” means interventions provided as a supplement to those regularly provided by the LEA, including services provided in accordance with an IEP, that are designed to meet students’ needs for behavioral, social, emotional, and other integrated student supports, in order to enable students to engage in, and benefit from, the supplemental instruction being provided.
- “Students at risk of abuse, neglect, or exploitation” means students who are identified as being at risk of abuse, neglect, or exploitation in a written referral from a legal, medical, or social service agency, or emergency shelter.

EC Section 43522(b) identifies the seven supplemental instruction and support strategies listed below as the strategies that may be supported with ELO Grant funds and requires the LEA to use the funding only for any of these purposes. LEAs are not required to implement each supplemental instruction and support strategy; rather LEAs are to work collaboratively with their community partners to identify the supplemental instruction and support strategies that will be implemented. LEAs are encouraged to engage, plan, and collaborate on program operation with community partners and expanded learning programs, and to leverage existing behavioral health partnerships and Medi-Cal billing options in the design and implementation of the supplemental instruction and support strategies being provided (*EC* Section 43522[h]). The seven supplemental instruction and support strategies are:

1. Extending instructional learning time in addition to what is required for the school year by increasing the number of instructional days or minutes provided during the school year, providing summer school or intersessional instructional programs, or taking any other action that increases the amount of instructional time or services provided to students based on their learning needs.
2. Accelerating progress to close learning gaps through the implementation, expansion, or enhancement of learning supports including, but not limited to, any of the following:
 - a. Tutoring or other one-on-one or small group learning supports provided by certificated or classified staff.
 - b. Learning recovery programs and materials designed to accelerate student academic proficiency or English language proficiency, or both.
 - c. Educator training, for both certificated and classified staff, in accelerated learning strategies and effectively addressing learning gaps, including training in facilitating quality and engaging learning opportunities for all students.
3. Integrated student supports to address other barriers to learning, such as the provision of health, counseling, or mental health services, access to school meal programs, before and after school programs, or programs to address student trauma and social-emotional learning, or referrals for support for family or student needs.
4. Community learning hubs that provide students with access to technology, high-speed internet, and other academic supports.
5. Supports for credit deficient students to complete graduation or grade promotion requirements and to increase or improve students' college eligibility.
6. Additional academic services for students, such as diagnostic, progress monitoring, and benchmark assessments of student learning.
7. Training for school staff on strategies, including trauma-informed practices, to engage students and families in addressing students' social-emotional health needs and academic needs.

As a reminder, *EC* Section 43522(g) requires that all services delivered to students with disabilities be delivered in accordance with an applicable IEP.

Fiscal Requirements

The following fiscal requirements are requirements of the ELO grant, but they are not addressed in this plan. Adherence to these requirements will be monitored through the annual audit process.

- The LEA must use at least 85 percent (85%) of its apportionment for expenditures related to providing in-person services in any of the seven purposes described above.
- The LEA must use at least 10 percent (10%) of the funding that is received based on LCFF entitlement to hire paraprofessionals to provide supplemental instruction and support through the duration of this program, with a priority for full-time paraprofessionals. The supplemental instruction and support provided by the paraprofessionals must be prioritized for English learners and students with disabilities. Funds expended to hire paraprofessionals count towards the LEAs requirement to spend at least 85% of its apportionment to provide in-person services.
- An LEA may use up to 15 percent (15%) of its apportionment to increase or improve services for students participating in distance learning or to support activities intended to prepare the LEA for in-person instruction, before in-person instructional services are offered.
